This is a Regatta open to all classes of mono hulls and catamarans. One Design Classes that have participated in the past include: Lightning, Comet, Mutineer, Laser and Hobie. Cabin Boats will be scored using a USSA approved handicapping system.

To ensure trophies for a separate class, at least 4 boats must pre-register by Sept 29.

Awards, trophies, and raffle will be awarded at the VSA pavilion following the races on Sunday.

Approved USSA starting signal sequence will be used.

All fleets (One Design, Cabin boats, etc.) will use a common start/finish line and will have a suitable course.

No Lunches will be available at Valley. Please bring your own provisions!

Camping is available on the VSA grounds.
